

## Disclosure Pursuant to California Voluntary Carbon Markets Disclosure Act (AB 1305)

The Voluntary Carbon Markets Disclosure Act, California Assembly Bill No. 1305 (AB 1305), was signed into law by California on October 7, 2023. This new state law requires covered business entities to disclose certain specific information regarding the sale and use of certain voluntary carbon offsets and claims of net-zero emissions, carbon neutrality, or significant greenhouse gas emissions reductions in California.

Capital Power Corporation through its affiliates, including, Capital Power Energy Marketing L.P. and Capital Power Energy Marketing (US) Inc. procures, manages inventories of, and retires voluntary carbon offsets for the purposes of marketing and selling to counterparties through Capital Power Corp. affiliates. Throughout this disclosure, Capital Power Corporation and its affiliates are referred to as “Capital Power.”

Capital Power provides the following disclosure statement in accordance with AB 1305. The disclosure is based on information reasonably available and known to Capital Power and includes links to information and applicable project and registry webpages. The disclosure is based on information available to Capital Power as of the posting date and may not reflect any new or updated project information.

### Disclosure for Marketing or Selling Voluntary Carbon Offsets

Under AB 1305, Capital Power may be considered to be marketing and/or selling certain voluntary carbon offsets within California. Capital Power provides the below information regarding the applicable carbon offset projects associated with the offset credits it marketed/sold within California in calendar year 2023.
